The United Keetoowah Band of Cherokee Indians (UKB) seeks to obligate any remaining Coronavirus State and Local Fiscal Recovery Funds (SLFRF) under the American Rescue Plan Act (ARPA). In accordance with the final ruling and remain in compliance. The UKB will accept application from Exclusive Tribal members until the deadline of December 24, 2024, and seeks to make such funding available to its Tribal population until September 30,2026 or until funding is expended. All exclusive UKB Tribal members will need to have an application on file, regardless of assistance need (immediate or future) to be eligible for assistance out of the UKB SLFRF/ARPA funding.

#### **Services:**

This award is limited to providing services to eligible exclusively enrolled UKB Tribal members. Services must meet the COVID-related expense categories as defined in the guidance from the United States Treasury. Covid-related expense categories are defined as:

- Public Health
- Negative Economic Impacts
- Revenue Replacement
- Administrative
- Emergency Relief from Natural Disasters
- Education/Job Training

#### **Assistance guidelines:**

Exclusive enrolled UKB members with an application submitted prior to the deadline will be eligible for assistance through September 30, 2026. Assistance will be provided on a bi-yearly basis (every 6 months) with the following services:

- Educational assistance
- Utility assistance
- Food assistance
- Job assistance: clothing/uniforms, tools, vehicle repairs necessary for work

## To qualify for the Inflation Reduction Act 23 (ARP) Fund, the applicant must:

- Be an exclusive tribal member of the United Keetoowah Band of Cherokee Indians.
- Have been Financially impacted & experienced hardship as a result of Inflation Reduction.
- Complete an application form that verifies the two requirements listed above.
